FIRST AID TREATMENT:

NOODHULPBEHANDELING:

Ingeasem: Verwyder onmiddellik vanaf blootstelling na vars lug. Indien asemhaling ophou, pas kunsmatige asemhaling toe. Dien suurstof toe as asemhaling moeilik is. Verkry mediese hulp indien nodig .

Ingesluk: Laat pasiënt mond deeglik uitspoel met water. Gee water om die materiaal te verdun indien slagoffer wakker is en sonder stuiptrekings. **Moet NIE** braking veroorsaak nie. Indien spontane braking voorkom, laat die slagoffer vooroor leun met die kop na onder om te verhoed dat braaksel ingeasem word, spoel mond en gee nog water.
