

## RESISTANCE WARNING:

For resistance management, **Luna Privilege** is a group code 7 fungicide. Any fungus population may contain individuals naturally resistant to **Luna Privilege** and other group code 7 fungicides. The resistant individuals can eventually dominate the fungus population if these fungicides are used repeatedly. These resistant fungi may not be controlled by **Luna Privilege** or any other group code 7 fungicides.

### COMPATIBILITY:

- **Luna Privilege** can be used on grapes in tank mixtures with any one of the following: **Decis Forte** (Reg. No. L6563), **Flint Max** (Reg. No. L8827), **Profiler** (Reg. No. L8596), **Movento** (Reg. No. L8559).
- **Only one tank mixture application of Luna Privilege and Profiler** is allowed at the 10 ml/100 l Powdery mildew rate of **Luna Privilege** and the application must be done before end of flowering (BBCH 69) (See point 4 of use restrictions below.)
- Tank mixtures of **Luna Privilege** with other than the above mentioned products are not recommended.
- Low volume sprays on table grapes should not be applied as tank mixtures with any other products.
- Allow 7 days between the application of **Luna Privilege** and a dust application or products not listed above and do not apply **Luna Privilege** in combination with wetter/stickers or as a tank mixture with trace or macro element sprays in grapes.

Pour the required quantity of **Luna Privilege** into the water while agitating. Do not allow the **Luna Privilege** spray mixture to stand any length of time before using.

**2. Low volume application on grapes:**

**Luna Privilege** can be applied as a low volume application. The volume of product needed per hectare should be calculated from the corresponding high volume application rate. The concentration of the spray mix should not exceed four times (4X). On wine grapes apply in at least 250 ℓ/ha. Ensure even coverage. On table grapes for sprays at the start of ripening and shortly before harvest apply in 500 - 700 ℓ water/ha with a suitably calibrated mist blower up to the point of run-off ensuring even coverage and delivery of a droplet spectrum with a VMD of 150 - 200 µm. Sprays should not be applied past the point of run-off on the berries. The volume of product needed per hectare should be calculated from the high volume application rate applicable to the particular vineyard at that growth stage.

**3. SDHI-containing fungicides:**

- The total number of SDHI fungicides per year for all diseases, solo or in mixture with effective mixing partners from different cross-resistance groups, shall not be more than 50% of the total number of applications.
- If used solo, apply SDHI fungicides in strict alternation with fungicides from a different cross-resistance group.
- If used in a mixture, apply SDHI fungicides in a maximum of 2 consecutive applications.
- Please refer to FRAC guidelines.

**4. Use restrictions:**

- For the control of **Powdery mildew**: A maximum of two (2) **Luna Privilege** applications per season at the registered rate of 10 mℓ / 100 ℓ with a maximum water volume of 1500 ℓ water / ha. Do not apply second application later than berries goat-sized, bunch begin to hang stage (BBCH 73).
- For the control of **Botrytis rot**: A single **Luna Privilege** application per season at the registered rate of 35 mℓ / 100 ℓ with a maximum water volume of 725 ℓ water / ha. Apply between beginning of flowering (BBCH 62) to the end of flowering (BBCH 69) at a maximum of 262 mℓ / ha per season. No applications of **Profiler** are allowed when **Luna Privilege** is applied for Botrytis rot. If **Profiler** is used for downy mildew control, a **Luna Privilege** application for Botrytis rot is not allowed.
- For the control of **Powdery mildew** and **Downy mildew**: One (1) **Luna Privilege** application at registered rate of 10 mℓ / 100 ℓ and one (1) **Profiler** application @ 225 g / 100 ℓ are allowed, not later than berries goat-sized stage. If **Luna Privilege** and **Profiler** are applied as a tank mixture the treatment must be applied not later than the end of flowering. In case of tank mixture no further applications of **Luna Privilege** and **Profiler** are allowed.

##### 2. Lae volume toediening op druive:

**Luna Privilege** kan ook toegedien word as 'n lae volume bespuiting. Die hoeveelheid produk benodig per hektaar moet bereken word van die dienoorseenkomstige hoë volume toedieningshoeveelheid. Die konseptrasie van die spuitmengsel mag nie vier keer (4X) die konseptrasie oorskry nie. Dien 'n spuitvolume van ten minste 250 ℥/ha toe op wyndruwe. Verseker egalige bedekking. Geen toedienings met **Profiler** word toegelaat wanneer **Luna Privilege** toegedien is vir Botritis verrotting nie. Indien **Profiler** gebruik word vir die beheer van Donsskimmel, is 'n **Luna Privilege** toediening vir Botritis verrotting nie toelaatbaar nie.
- Vir die beheer van **Poeieragtige skimmel en Donsskimmel** is slegs 'n enkele (1) toediening van **Luna Privilege** toelaatbaar teen die geregistreerde dosis van 10 ml / 100 ℥ en een (1) **Profiler** toediening teen 225 g / 100 ℥ toelaatbaar, maar nie later as BBCH 73 nie.
