Spirotetramat caused male reproductive toxicity in the presence of general toxicity in the rat at very high experimental dose levels. There were no effects on male fertility in mice and dogs. The reproductive

toxicity seen with Spirotetramat is due to an overwhelmed elimination capacity at high doses. The high dose levels needed for this effect cannot be achieved even in a worst case exposure scenario.

Assessment developmental toxicity

Spirotetramat caused developmental toxicity only at dose levels toxic to the dams. Spirotetramat caused a delayed foetal growth, an increased incidence of variations.

Aspiration hazard
